## **Responsibility For Personal Property.**

I, \_\_\_\_\_, fully understand that upon leaving the Tree of Life Center residential program, either through eviction or elopement, I must take all of my personal property with me.

In the event of elopement, all items of clothing and toiletries acquired from the Tree of Life Center during my stay will remain the Tree of Life Center's property. Further, I release the Tree of Life Center from any and all liability regarding any of my personal property left behind by me at the facility upon my elopement or eviction. Personal items left behind me are designated by me to be a donation to the Tree of Life Center.

No account money held in trust will be released to a resident prior to 48 hours of his leaving the Tree of Life Center. Funds will then be issued by check to the person placing those funds in the trust account. Residents must call the Director of Operations within 24 hours of their leaving time for reimbursement or account funds will be forfeited to the Tree of Life Center.

## Tree of Life Center House Rules

1. No alcohol or drugs on premises.
2. No one is to be under the influence of drugs or alcohol.
3. All prescribed medications must be turned in to the Director.
4. No drug or alcohol paraphernalia allowed on premises.
5. No cursing or foul language allowed on premises.
6. No violence of any kind, yelling, threatening, or intimidation.
7. All smoking must be done in the back.
8. Mandatory attendance of all classes, prayer meetings, Bible studies, Church services, etc.
9. Curfew is at 8:00p.m.
10. Bedtime is at 10:30 p.m. and 11:30 p.m. on weekends.
11. Rooms and personal items must be kept clean. Personal hygiene must be kept clean.
12. No defacing or destruction of the house inside or out.
13. All incidents of any type must be reported to the Director so they can be corrected immediately.
14. Please do your own dishes between 9am to 5pm and clean up after yourself in the bathroom.
15. You are a guest at the Tree of Life Center.
16. This is not a government funded institution.
17. We will treat you as a guest. We will respect you. If your behavior is not that of a welcomed guest, we will ask that you leave the premises. If you do not do so in a peaceful and prompt manner, we will be forced to have you legally removed by the P.B.S.O.
18. Failure to comply with any of these rules may result in a disciplinary action up to and including dismissal from the premises. God bless you.
